For reference, from Washington Youth Soccer Bylaws:

6.3.4 **Voting** - Each Council Member shall have votes per the following list:

- (a) Directors shall have one vote each.
- (b) District Commissioners shall have one vote each.
- (c) MARs shall have votes based on the Washington Youth Soccer player registration of their Member Association.

This determination shall be based on Washington Youth Soccer registered players of record for the prior Seasonal Year, per the following schedule:

0 to 1000 players	one (1) vote
1001 to 2500 players	two (2) votes
2501 to 3500 players	three (3) votes
3501 to 4500 players	four (4) votes
4501 to 5500 players	five (5) votes
5501 to 6500 players	six (6) votes
Over 6500 players	seven (7) votes
