Agenda Item #1 –U11-14 Challenge Cup 2 state cup schedule

Discussion on the creation and scheduling of Challenge Cup 2 for RCL level 3-4 and below.

Agenda Item #2 – Judicial Operation Document

Perry provided an explanation of the process and inputs to create the proposed Judicial Operating Document. The document was prepared in accord with our policy on change to the operating document and was provided more than the 45 days in advance of the SOC meeting that they will be voted on. Jillian provided a large amount of input. No technical or process changes are being made.

Result: Motion to approve and put on the August agenda. Motion Passed.

Agenda Item #3– Rules of Competition Operation Document

Perry provided an explanation of the time line since February and the need to review and change this operating document. A spread sheet has been prepared that shows the similarity and differences from several sources. Sources are: Rules of Competition operating document, Gary White proposal to the RC's, US Youth web site, US Youth Sam Snow (Feb. 2012), USSF Claudio Renya, USSF Best Practices. Discussed what the rules are and what is happening. There is a desire to be less restrictive and more flexible or adaptable to change.

Result: Perry will contact Tom Ament for a meeting with a small group of the RCS to go over rules. Brain and Lance volunteered to be part of this meeting to initiate the discussion.

Agenda Item #4– Director of Coaching Pass

During state cup the Director of Coaching pass was used. The group was very positive about how this tool worked at state cup and agreed with some criteria should be used for league matches.
